### MGT447: Managing Food Emergencies: Strategies for a Community Response

**Description:** This course provided by National Center for Biomedical Research and Training at Louisiana State University teaches participants how to manage food emergencies using the emergency operations center (EOC), Incident Command System (ICS) principles, and best management practices. Participants will manage a fictional food emergency using the guidelines and strategies of the Incident and Unified Command systems. The scenario will advance with every module, beginning with Module 2, from the point that a foodborne outbreak is detected. The scenario will progress throughout the modules from surveillance and into the transition to recovery. In Module 7, participants will engage in an after-action discussion to assess their current preparedness for a food emergency and the value of using ICS principles and practices, and adding Emergency Management as a food emergency response partner.

**Prerequisites:** None, however it is recommended that participants successfully complete the FEMA independent study course IS-100.B: Introduction to the Incident Command System prior to attending this class. **Target Audience:** Agricultural, Emergency Management, Emergency Medical Services, Fire Service, Governmental Administrative, Healthcare, Law Enforcement, Public Health, Veterinarians
